7. PROJECT STATUS REPORTS; QUINCY WYLUPEK, ENGINEERING PROJECT MANAGER

- **CGC Runway Extension** - A "Vector System" will cost 61,000. This data is intended to support the FAA requirement of 500 operations by aircraft requiring greater than a 5,000' runway.

Alternative data collection systems are GARD or VIRTOWER. Will request a demonstration of each during the April meeting.

- **CGC T-Hangars Phase 2** - Expect CO by the end of the month. Anticipating having full occupancy by May 1
- **Generator for CGC FBO Facility** - Scope of work to relocate and PO has been issued. Contractor has disconnected the generator at KINF and has submitted the permit application to the County.
- **CGC Runway Rehab** - Plans are 100% and Procurement Authorization has been created and routed to go out to bid.
- **INF Taxiway A1 Relocation** - FDOT grant has been received and approved by BOCC. A contract offer has been sent to the Contractor.
- **Taxiway B and C and Aprons Rehab at North End** - FDOT grant has been received and approved by BOCC. A contract offer has been sent to the Contractor.
- **INF Airspace Study-Obstruction Removal Phase I** - Revised airspace exhibits have been sent to FAA; had Zoom meeting with the FAA on 3/1/21.
- **INF FBO Hangar Door Replacement** - project is out to bid. Bids due in on 3/24/21.
- **INF Parking Lot** - FDOT Grant offer has been received and scheduled to go before the BOCC on March 23, 2021.
- **Venable Tree Clearing** - Scope of work has been received in the amount of \$38,000. Procurement Authorization will be routed and then added to the BOCC agenda.
