A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CITRUS COUNTY, FLORIDA, ESTABLISHING WATERCRAFT LAUNCH FEES, PROVIDING FOR PENALTIES AND ENFORCEMENT; PROVIDING FOR THE USE OF REVENUE GENERATED FROM THE FEES; PROVIDING FOR A REPEALER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with Florida Statutes, Chapter 125.01, the Board of County Commissioners has the power to carry on county government and adopt ordinances and resolutions necessary for the exercise of its powers, prescribe fines and penalties for the violation of ordinances in accordance with law;

WHEREAS, on ~~February 9, 2021~~ ~~August 13, 2019~~ at ~~29:00 P.p.A.~~ M. the Board of County Commissioners, sitting as the Governing Body of the Citrus County Parks and Recreation Division, held a public ~~hearing~~ ~~workshop~~ to receive public comment regarding [watercraft](#) launch fees for use of County boat ramps, the amount of [watercraft](#) launch fees, type of [watercrafts vessels](#) to be charged and the use of the fees;

WHEREAS, it is the intent of the Board of County Commissioners to promote, protect, and improve the health, safety, and welfare of the citizens of Citrus County, Florida;

WHEREAS, the Board of County Commissioners of Citrus County, Florida, finds that it is in the best interest of the public health, safety and welfare to assess a fee for the launching of watercraft via a trailer from County owned boat ramps;

WHEREAS, the Board of County Commissioners of Citrus County, Florida, adopted Ordinance No. _____ ~~2021~~ - _____ providing that launch fees are to be set by resolution of the Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Citrus County, Florida in Regular session this ___ day of _____, 2021, as follows:

1. The launch fees for County owned boat ramps shall be as follows:
 - a. Daily launch fee for ~~launching a motorized watercraft vessel from a Citrus County boat ramp~~ watercraft transported via trailer - \$10.00
 - ~~a.b.~~ Daily launch fee for launching a non-motorized watercraft from a Citrus County boat ramp - \$5.00
 - c. Annual Pass fee for a non-resident of Citrus County launching a motorized watercraft vessel from a Citrus County boat ramp ~~watercraft transported via trailer~~ - \$50.00
 - ~~b.d.~~ Annual Pass for non-resident of Citrus County launching a non-motorized watercraft from a Citrus County boat ramp - \$25
 - e. Annual Pass fee for resident of Citrus County launching a motorized watercraft vessel from a Citrus County boat ramp ~~senior citizens 65 and older for watercraft transported via trailer~~ - \$25.00
 - f. Annual Pass fee for resident of Citrus County launching a non-motorized watercraft from a Citrus County boat ramp - \$12.50
 - ~~c.~~
 - ~~d.~~ Annual Pass fee for veterans for watercraft transported via trailer - \$25.00
 - ~~e.~~ Annual Pass fee sold on "annual half price day" for watercraft transported via a trailer - \$25.00
 - g. Fees will be pro rated on a quarterly basis for resident and non-resident annual passes.
